## RESOLUTION NO. 2022-18

AN RESOLUTION AUTHORIZING THE MAYOR TO TAKE ALL NECESSARY ACTIONS AND EXECUTE ANY AN ALL RELATED DOCUMENTS TO FINALIZE THE ACCEPTANCE OF GRANT MONEYS FOR IMPROVEMENTS TO THE DEPOT AND COMPLETION OF THOSE IMPROVEMENTS AND DECLARING AN EMERGENCY

WHEREAS, the City of Wellston owns the Depot in Pride Park and was the beneficiary of a \$200,000.00 grant through ODNR to make much needed improvements to the building.

WHEREAS, the City wishes to finalize the acceptance of such funds and provide for the completion of the improvements.

BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

Section One: The Mayor of City of Wellston, his representative and any other official is hereby authorized to take all necessary actions and execute any and all related documents to finalize acceptance of ODNR grant funds and completion of improvements to the Depot.

Section Two: This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

<u>Section Three:</u> In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Four: It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
