# Wellston City Council Meeting Minutes July 21, 2022

- The Land Bank has received funds for demolitions. The 3 properties in Wellston include: The Louvee, Coops Bar, and King's Pool Hall. This list will also include a few houses in Wellston as well.
- The Mayor had a meeting with Ken Reed of OVRDC to come up with regional projects which will be established with grant funds by the Appalachian Community Grant Program.
- The Mayor has suggested that a Park/Recreation Levy be placed on the ballot to build and financially support a City Pool.
- The Mayor would like to see a Recreation Department in the City once again.

#### **Service Director**

- The Finance Committee was asked to meet the following week to mitigate budget issues such as rising fuel costs, the cemetery, and the new Infrastructure Crew.
- Cemetery Plots are almost gone and needs immediate action.
- RV Park/Strip Mine Project is ongoing.
- The Lookout Drive Paving Project has started.
- Half of the sidewalks have been replaced in the ongoing Depot Project. There will be parking on both ends and the drainage has been fixed. The interior work is slotted to begin in 2 weeks.
- The sidewalks on Pennsylvania Avenue will be addressed soon.
- The work at the WinMac subdivision has been completed and is successful.
- The Red-Light project has begun, but there is no price on the crosswalk, and we are waiting for the sensors to be delivered.
- New York and Broadway waterline project is almost finished. The Service Director brought in a piece of the old water line to show Council.
