ORDINANCE NO. 2022-46

AN ORDINANCE APPROVING ADDITIONAL APPROPRIATIONS IN THE GENERAL FUND, TRANSFERRING FUNDS TO THE STREET LEVY CAPITAL IMPROVEMENT FUND AND DECLARING AN EMERGENCY

WHEREAS, the Auditor for the City of Wellston desires to appropriate additional money in the General Fund for the purpose of transferring those funds to the Street Levy Capital Improvement Fund, and

WHEREAS, pursuant to Ohio Revised Code Section 5705.14(E) money may be transferred from the General Fund to any other fund; and

BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

Section One: The appropriation ordinance as it relates to the following fund is hereby modified so as to appropriate additional monies as follows:

GENERAL 101-7080-590415 \$100,00.00 General Fund Carryover (Civil/ Transfer Out)

Section Two: The Auditor is authorized to transfer the herein appropriated monies to the Street Levy Capital Improvement Fund, line item 211-6040-550400/ Street Paving.

Section Three: This Ordinance is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

Section Four: In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Five: It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
