RESOLUTION NO. 2023-38

**A RESOLUTION OF NECESSITY FOR A PARKS AND RECREATIONAL SERVICES LEVY AND REQUESTING THE AUDITOR OF THE COUNTY OF JACKSON TO CERTIFY THE TOTAL TAX VALUATION AND REVENUE THAT WILL BE GENERATED UPON AN ADDITIONAL LEVY OF 5.0 MILL FOR THE PURPOSE OF MAINTAINING PARK AND RECREATIONAL SERVICES INCLUDING THE DESIGN, CONSTRUCTION AND OPERATION OF A POOL FOR THE CITY OF WELLSTON AND DECLARING AN EMERGENCY.**

WHEREAS, the legislative authority of the City of Wellston has determined that without the levy for the purpose of maintaining park and recreational services including the design, construction and operation of a City pool there will be insufficient funds for said purposes; and

WHEREAS, the Parks and Recreational Services Levy issue will be presented to the Jackson County Board of Elections for inclusion on the ballot for the 2023 general election to be held on November 7, 2023 to be submitted to the electors of the entire City of Wellston; and

WHEREAS, in order to determine the revenue generated by the additional Parks and Recreational Services levy, it is necessary to have the County Auditor certify to this Council the total tax valuation and revenue that will be generated by a 5.0 mill levy pursuant to R.C. section 5705.19(H) for the purposes related to the park and recreational services as set forth above; and

WHEREAS, the term of years of the tax shall be a continuing term commencing with the 2023 Tax Duplicate year and first due in calendar year 2024 and is to be levied on the entire territory of the City of Wellston; and

WHEREAS, the funds generated by the levy to be requested are necessary to preserve and protect the health, safety and welfare of the City and its citizens and this matter and is subject to a deadline of August 9, 2023, to be included on the general election ballot and, therefore, this matter constitutes an emergency.


NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AUTHORITY OF THE CITY OF WELLSTON, FOR THE PURPOSE OF MAINTAINING PARK AND RECREATIONAL SERVICES INCLUDING THE DESIGN, CONSTRUCTION AND OPERATION OF A POOL FOR THE CITY OF WELLSTON, THAT AN ADDITIONAL PARKS AND RECREATIONAL SERVICES LEVY OF A CONTINUING PERIOD OF TIME IS NECESSARY AND THAT THE JACKSON COUNTY AUDITOR IS REQUESTED TO CERTIFY TO THE CITY OF WELLSTON THE TOTAL TAX VALUATION AND REVENUE THAT WILL BE GENERATED UPON AN ADDITIONAL 5.0 MILL FOR THE PARKS AND RECREATIONAL SERVICES LEVY AND THAT THIS MATTER CONSTITUTES AN EMERGENCY.

In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Resolution shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this resolution were adopted in an open meeting of this council and that the deliberations of

the council and any of its committees resulted in such formal action, were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


