RESOLUTION NO. 2023-46

A RESOLUTION AUTHORIZING AN EXPENDITURE NOT TO EXCEED \$10,000 TO BE PAID TO THE OHILLCO SOCIETY FOR USE IN CONDUCTING AND PROMOTING EVENTS AS PART OF THE CITY'S SESQUICENTENNIAL CELEBRATION AND DECLARING AN EMERGENCY

WHEREAS, the City of Wellston is hosting events celebrating the City's sesquicentennial throughout the year to promote the City of Wellston and to contribute to the general welfare and prosperity of the City and the contentment of its inhabitants; and

WHEREAS, consistent with the purpose to contribute to the general welfare and prosperity of the City and the contentment of its inhabitants, this legislative body authorizes an expenditure not to exceed \$10,000 to the OHillCo Society to promote and conduct events to be used for the City's Sesquicentennial Celebration; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WELLSTON, STATE OF OHIO:

Section One. That the City of Wellston, Ohio shall cause to be paid to the OHillCo Society the sum not to exceed \$10,000 for the operation and promotion of events as part of the sesquicentennial celebration of the City of Wellston and that the event is in furtherance of the general welfare and prosperity of the City and will contribute to the contentment of its inhabitants.

Section Two: This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health, or safety of the City of Wellston due to the time required for preparation prior to the event. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

Section Three: In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Four: It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


