ORDINANCE NO. 2023-34

AN ORDINANCE ESTABLISHING THE ANNUAL SALARY OF THE CITY AUDITOR AT \$35,000.00 PLUS BENEFITS TO BE EFFECTIVE JANUARY 1, 2024.


WHEREAS, this legislative authority finds it beneficial to the City to repeal and amend all prior ordinances or resolutions of this body that established the salary of the City Auditor in an amount other than \$35,000, and that this Ordinance shall establish the Auditor's salary to be an annual salary of \$35,000.00 to be effective as of January 1, 2024; and

WHEREAS, in addition to the annual salary, the City Auditor shall continue to participate in the OPERS retirement system and to receive health insurance benefits at the same cost paid by other full-time employees of the City Auditor's Office; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF WELLSTON, OHIO THAT ALL PRIOR ORDINANCES OR RESOLUTIONS THAT ESTABLISHED AN ANNUAL SALARY FOR THE CITY AUDITOR IN AN AMOUNT OTHER THAN \$35,000.00 ARE HEREBY REPEALED AND AMENDED AND THE ANNUAL COMPENSATION AND BENEFITS PAID TO THE CITY AUDITOR IS HEREBY ESTABLISHED TO BE \$35,000.00 IN ADDITION TO HEALTH INSURANCE AND RETIREMENT BENEFITS AVAILABLE TO OTHER EMPLOYEES OF THE CITY AUDITOR'S OFFICE AND THAT THIS SALARY CHANGE SHALL OCCUR ON JANUARY 1, 2024, THAT DATE BEING THE NEXT TERM OF OFFICE AND THAT THIS SALARY CHANGE SHALL OCCUR ON JANUARY 1, 2024, THAT DATE BEING THE NEXT TERM OF OFFICE.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this ordinance were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
