- Second Reading of Resolution No. 2023-57- A Resolution authorizing Mayor Anthony Brenner to prepare and submit an application to participate in the Ohio Public Works Commission State Capital Improvement Program(s) and to execute contracts as required.

A Motion was made by Lemaster to amend the legislation to say, "2nd Street Paving" instead of "New York and Broadway Phase 3 Street Improvements." Norris seconded the motion, and the which was approved by all in attendance by roll call vote.

Discussion: This pertains to Phase 3 of the New York and Broadway Improvements Project.

- Service Director Stacy Camp began with giving an update on the New York/Broadway Improvements. He reports that the New York Avenue portion of the project will be shut down next week due to the casting company is having problems keeping up with basin production. Broadway is still going "full speed." The timelines for paving the roads are looking to be around November. The Storm portion of the project is 45% complete.


Fire- none

Zoning- Code Report Received; last round of mowing is finishing; extra mowing was performed for the festival; Pelletier acknowledged and commended the hard-work his crew puts in yearly. Lemaster commented that the parks have been in great condition. Norris questioned the Lake Road property. A case file was requested, but nothing new has been reported. Aerial photos are being taken at this point. Hudson noticed the number of condemnation notices on the code report. Pelletier explains that many of these problem properties were mitigated before the City actually pushed forward with demolition.

Police- A press release was issued concerning a vehicle which was pulled over for a simple violation. 107 grams of suspected fentanyl and 323 grams of suspected methamphetamine were discovered. Vinton County resident Bryan Wiseman was incarcerated and had a felony warrant from the Vinton County Sheriff's Office. Robinson commended the officers involved.
