**RESOLUTION NO. 2023-60**

**A RESOLUTION APPROVING ADDITIONAL APPROPRIATIONS IN THE GENERAL FUND AND DECLARING AN EMERGENCY**

BE IT RESOLVED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

**Section One:** The appropriation Resolution as it relates to the following funds is hereby modified so as to appropriate additional moneys as follows with the source being carryover in each respective fund or from funds otherwise detailed:

See Attached 'Exhibit A' incorporated herein as if fully rewritten.

**Section Two:** This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

**Section Three:** In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

**Section Four:** It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
