RESOLUTION NO. 2023-71

A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF WELLSTON TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE 2023-2024 OHIO DEPARTMENT OF TRANSPORTATION'S "TRANSPORTATION ALTERNATIVES PROGRAM (TAP)" AND TO EXECUTE CONTRACTS AS REQUIRED AND DECLARING AN EMERGENCY

WHEREAS, the Transportation Alternatives Program provides financial assistance to political subdivisions for non-motorized transportation facilities, historic transportation preservation, and environmental mitigation and vegetation management activities; and

WHEREAS, the City of Wellston is planning to make capital improvements to New York Avenue from 10th street to 14th Street; and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the Transportation Alternatives Program.

NOW THEREFORE, BE IT RESOLVED by the CITY OF WELLSTON:

Section One: The Mayor is hereby authorized to apply to ODOT for funds as described above.

Section Two: The Mayor is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

Section Three: This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health, or safety of the City of Wellston, in that it is necessary to approve this resolution to direct possible funds from the Ohio Department of Transportation. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

Section Four: In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

Section Five: It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public

and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
