

Wellston City Council

Meeting Minutes

January 18, 2024

Meeting was called to order at 7 p.m. by President Rick Hudson by asking Council and others in attendance to stand for the Pledge. He then called for the roll call.

Councilpersons answering the roll call included: Angela Spangler; Hunter Skaggs; Fred Duby; Teresa Lemaster; Walter Norris; and Roaby Browning.

Elect At-Large

President Rick Hudson announced there were five interested parties in the vacant At-Large seat. He gave each applicant time to speak at the podium.

Police


- Chief Robinson presented WPD's yearly report.

- Lemaster questioned the vehicle to officer ratio and asked if it was feasible to keep so many cars (9) due to maintenance, parking, and insurance. The Mayor and Police Chief then explained the list of vehicles, which includes the unmarked chief's car, unmarked detective unit, Resource Officer, the side-by-side, and one cruiser must remain at the City Building at all times. This left 4-5 vehicles in rotation counting the aforementioned "problem" car.
