ORDINANCE NO. 2024-36

AN ORDINANCE TRANSFERRING APPROPRIATIONS FROM THE GENERAL CARRYOVER FUND TO THE REC FUND FOR PART TIME LABORER WAGES AND MAINTENANCE EXPENSES AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WELLSTON, STATE OF OHIO, as follows:

Section 1. The legislative authority of the City of Wellston hereby makes the following transfers as follows:


Section 2. This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, Ohio so that the funds can be available to cover wage related expenses as they may become owed and in a timely manner. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

Section 3. The Auditor is authorized to account for the activity authorized herein as is appropriate under the circumstances of this ordinance and in accordance with City policies and procedures, or as otherwise required by law. The City attorney is authorized to correct as he determines appropriate any clear scrivener or clerical error in this ordinance, and to provide a clean copy for the council clerk.

Section 4. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
