**ORDINANCE NO. 2024-43**

**AN ORDINANCE RENAMING FUND 209 FROM THE UDAG REVOLVING LOAN FUND TO THE RPIG FUND AND ADDING ADDITIONAL EXPENSE AND REVENUE LINES AND DECLARING AN EMERGENCY.**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WELLSTON, STATE OF OHIO, as follows:

**Section 1:** Fund 209 is hereby renamed from the UDAG Revolving Loan Fund to the new name of the RPIG fund and additional expense and revenue lines are created therein as set forth below:

Additional Expense Lines:

209-4030-530391 Administration Costs  
209-4030-550200 Improvements  
209-4030-590430 Other

Additional Revenue Lines:

209-3000-437400 Grants  
209-9000-499300 Other

**Section 2.** This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, Ohio as the renaming of the fund is upon the recommendation of the State Auditor and the creation of the revenue and expense lines are necessary to better align with State grant policy and to properly account for revenue and expenses in the RPIG fund. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor as provided in Ohio Revised Code Section 731.30.

**Section 3.** The Auditor is authorized to account for the activity authorized herein as is appropriate under the circumstances of this ordinance and in accordance with City policies and procedures, or as otherwise required by law. The City attorney is authorized to correct as he determines appropriate any clear scrivener or clerical error in this ordinance, and to provide a clean copy for the council clerk.

**Section 4.** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
