**RESOLUTION 2024-67**

**RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY.**

WHEREAS, the Budget Commission of Jackson County, Ohio, has established the Tax Budget for the next succeeding fiscal year commencing January 1, 2025; and

WHEREAS, The Budget Commission of Jackson County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten-mill tax limitation; therefore be it:

**RESOLVED, By the Council of the City of Wellston, Jackson County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further**

**RESOLVED, That there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as set forth in Schedule A and Schedule B, as attached hereto together with the Certificate To Copy to be completed by the Clerk of the Council of the City.**

**RESOLVED, that this matter constitutes an emergency as there is a deadline of September 30, 2024 by which the certification must be approved and the Clerk of this Council is hereby directed to certify a copy of this Resolution to the Jackson County Auditor and that this action is necessary for the preservation of the health, safety and welfare of the City.**

In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Resolution shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this resolution were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
