## Resolution No. 2025-04

A RESOLUTION AUTHORIZING THE MAYOR OF WELLSTON TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER POLLUTION CONTROL LOAN FUND (WPCLF) or AGREEMENT ON BEHALF OF THE CITY OF WELLSTON FOR DESIGN OF WASTEWATER FACILITIES; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN

Whereas, the City of Wellston seeks to upgrade its existing wastewater facilities;

Whereas, the City of Wellston intends to apply for Water Pollution Control Loan Fund (WPCLF) for the design of the wastewater facilities; and

Whereas, the Ohio Water Pollution Control Loan Fund (WPCLF) requires the government authority to pass legislation for application of a loan and the execution of an agreement as well as designating a dedicated repayment source.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Wellston, Ohio:

SECTION 1. That the Mayor of Wellston be and is hereby authorized to apply for a WPCLF loan, sign all documents for and enter into a Water Pollution Control Loan Fund (WPCLF) with the Ohio Environmental Protection Agency and the Ohio Water Development Authority for the design of wastewater facilities on behalf of the City of the City of Wellston, Ohio.

SECTION 2. That the dedicated source of repayment will be through user fees from the sewer funds.

In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Resolution shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
