A Motion to Adopt and Pass was made by Phillips, seconded by Spangler, and approved by all in attendance.

• First Reading of Resolution No. 2025-31- A Resolution authorizing the Mayor, Service Director, and any other necessary official to enter into an agreement with the County of Washington regarding the custody, supervision, confinement, and board of prisoners. Sponsor:

Discussion: yearly; the cost is \$100 per day

• First Reading of Ordinance No. 2025-32- An Ordinance for the transfer of funds from the 606 Sewer Fund to the Engineering Fund and Declaring an Emergency.

Sponsor: Spangler

Discussion: The Mayor explained that this transfer is due to the leachate issues discussed at the previous Council meeting. The emergency will enable the Mayor to take action before summer.

A Motion to Suspend the Rules was made by Spangler, seconded by Boch, and approved by all in attendance.

A Motion to Adopt and Pass was made by Lemaster, seconded by Spangler, and approved by all in attendance.

• First Reading of Ordinance No. 2025-33- An Ordinance creating two new fund line items for the Recreation Fund and Declaring an Emergency.

Sponsor: Browning

Discussion: The Mayor stated there is no need for an emergency. This will enable the auditors to better track donations and spending.
