RESOLUTION NO. 2025-52

**A RESOLUTION BY THE COUNCIL OF THE CITY OF WELLSTON, OHIO  
AUTHORIZING THE MAYOR AND/OR SERVICE DIRECTOR TO ENTER INTO  
A CONTRACT WITH POLLARD ENTERPRISE, LLC FOR THE SALE OF  
WATER AND ESTABLISHING RATES AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Wellston, Ohio desires to enter into an agreement to sell City water to Pollard Enterprise LLC., and;

**WHEREAS**, Pollard Enterprise, LLC has interest in opening a laundry facility at 1473 South Pennsylvania Avenue under an agreed upon rate; and

**WHEREAS**, the current rate terms of this tentative agreement are \$5.01 per thousand gallons.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY  
OF WELLSTON, OHIO, AS FOLLOWS:**


**SECTION 1.** The Mayor and/or the Service Director of the City of Wellston, Ohio are hereby authorized to enter into a contract with Pollard Enterprise, LLC, for the sale of City Water at a rate consistent with the attached agreed upon proposal.

**SECTION 2:** It is hereby found and determined that all formal acts of this Council concerning and relating to adoption of this Resolution were adopted in an open meeting of this Council and deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION 3:** This matter constitutes an emergency in order that the funds may be placed in the appropriate account at the earliest possible date to be used as necessary for the benefit of the health, safety and welfare of the City. This Ordinance shall take effect and be in full force upon final passage.

**SECTION 4:** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.
