 First Reading of Ordinance No. 2025-74- An Ordinance approving Additional Appropriations in the Police Laborer Wages and PERS from General Carryover and Declaring an Emergency.

Discussion: Walton spoke on the loss of an officer and 2 other officers being off work. This appropriation will relieve overtime.

• First Reading of Ordinance No. 2025-75- An Ordinance creating Section 93.16 to be included in the City of Wellston's Codified Ordinance regulating the residential growing of cannabis plants within the City in a manner not to constitute a nuisance.

Sponsor: Browning

Discussion: Attorney Joe Kirby spoke that the City could not go against the ordinance of the state; however, the City could enact certain zoning and nuisance ordinances. The Division of Cannabis Control has set forth guidelines, but there is no regulation so the City can enact ordinances with no criminal penalties, only fines. Council questioned how many complaints have been received and the Service Director responded 2 complaints on the smell of the plants. This would be a code enforcement issue.

 First Reading of Ordinance No. 2025-76- An Ordinance by the Legislative Authority of the City of Wellston, Ohio, repealing and amending Ordinance No. 2021-59 and establishing the salary and benefits of the Chief of Police in the City of Wellston.

Sponsor: Lemaster

Discussion: This was discussed in a prior executive session. The chief's salary will now also follow the raises outlined in the police union contract.
